GST slashed tax rates doubled taxpayer base to 1.24 crore: Finance Ministry

New Delhi: The Finance Ministry on Monday said GST has reduced the rate at which people have to pay tax, helped increase compliance and doubled taxpayer base to 1.24 crore. On the first death anniversary of former Finance Minister Arun Jaitley, the ministry said before goods and services tax (GST), the combination of value-added tax (VAT), excise, sales tax and their cascading effect resulted in high standard rate of tax up to 31 per cent.

It is now widely acknowledged that GST is both consumer and taxpayer-friendly. While the high tax rates of the pre-

GST era acted as a disincentive to paying tax, the lower rates under GST helped to increase tax compliance, the ministry said. The number of assessees covered by the GST at the time of its inception were about 65 lakh. Now the assessees base exceeds 1.24 crore.

GST, which subsumed about 17 local levies, was rolled out on July 1, 2017. Jaitley held the finance portfolio in the first term of the Modi government since 2014. As we remember Arun Jaitley today, let us acknowledge the key role he played in the implementation of GST, which will go down in history as one of

the most fundamental landmark reforms in Indian taxation, the Ministry said.

Prime Minister, Modi remebers Arun Jaitley on first death anniversary. The multiple markets across India, with each state charging a different rate of tax, led to huge inefficiencies and costs of compliance. GST has reduced the rate at which people have to pay tax. The revenue neutral rate as per the RNR (Revenue Neutral Rate) Committee was 15.3 per cent.

Compared to this, the weighted GST rate at present, according to the RBI, is only 11.6 per cent, the ministry said.

Govt's fiscal measures prudent: RBI

Mumbai: RBI Governor Shaktikanta Das on Thursday appreciated the government's response to the Covid-19 crisis as being fiscally very prudent and very calibrated.

I cannot speak for the government. But I just want to say that in the central bank, as observers of what is happening in the country in the fiscal policy, I think the Government's response has been very prudent and very calibrated Das said.

The government was responsible in announcing the measures right from the start which focused on the poor and vulnerable people.

Prime Minister Narendra Modi had announced a Rs

20 lakh crore stimulus package, which included additional spending of about 2 per cent of GDP by the Government, as well as liquidity measures by the RBI.

Meanwhile, Das also welcomed the

government's strategy of consolidating public sector banks, saying lenders with large balance sheets will be helpful.

Current step of consolidation is a step in right direction.
